### LAW, BY-LAW, CODE OR OTHER ENACTMENT SUBMITTER INFORMATION

**Name** Name of the person who is submitting the law, by-law, code or other enactment.

**First Nation** The First Nation who is submitting the law, by-law, code, or other enactment or the First Nation on behalf of whom the law, by-law, code or other enactment is being submitted.

**Address** The mailing address for the person submitting the law, by-law, code or other enactment.

**Email** The email address for the person submitting the law, by-law, code or other enactment.

**Primary Phone** The primary phone for the person submitting the law, by-law, code or other enactment.

**Alternate Phone** The alternate phone for the person submitting the law, by-law, code or other enactment.
